- 4) To aware and conduct the programs for the tribal community about health problem and nutritious diet.

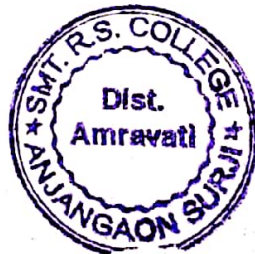

Radhabai Sarda College of Arts, Commerce & Science, Anjangaon Surji** will be responsible for any losses, financial and others which the other institutions may suffer. However, neither **Melghat Gramonnati Bahuudeshiya Sangh, Hatida, Tq- Dharni Dist. Amravati** and **Department of Home Economics, Smt. Radhabai Sarda College of Arts, Commerce & Science, Anjangaon Surji** will ensure that all activities in progress are allowed to complete successfully.
